Newspapers?!?

§5614(d) – The term "advertisement" or "public notice", wherever used in this section, shall mean a notice published at least ten days before the award of a contract in a newspaper of general circulation published in the municipality where the authority has its principal office or, if no newspaper of general circulation, in the county where the authority has its principal office. . .

- Performance and Payment Bonds
 - Performance
 - 5614(a)(3) No contract shall be entered into for construction or improvement
 or repair of a project or portion thereof unless the contractor gives an
 undertaking with a sufficient surety approved by the authority and in an amount
 fixed by the authority for the faithful performance of the contract.
 - 5614(a)(4) Payment
 - The contract must provide among other things that the person or corporation entering into the contract with the authority will pay for all materials furnished and services rendered for the performance of the contract and that any person or corporation furnishing materials or rendering services may maintain an action to recover for them against the obligor in the undertaking as though such person or corporation was named in the contract if the action is brought within one year after the time the cause of action accrued.
 - Public Works Contractors' Bond Law (8 P.S. Section 193.1)
 - "Any financial security, acceptable to and approved by the contracting body, including but not limited to, Federal or Commonwealth chartered lending institution irrevocable letters of credit and restrictive or escrow accounts in such lending institutions, equal to one hundred percent of the contract amount...."

Cooperative Purchasing

- Intergovernmental Relations, 62 Pa.C.S.A. Section 1901 et seq.
- Authority is a "Local public procurement unit"
- Fulfills Procurement Requirements (Section 1908)
- CoStars is the DGS Program



3. Rejecting Bids

5614(a)(1) (Services):

Except as set forth in paragraph (2), all construction, reconstruction, repair or work of any nature made by an authority if the entire cost, value or amount, . . . shall be done only under contract to be entered into by the authority with the *lowest responsible bidder* upon proper terms after public notice asking for competitive bids as provided in this section.

Section 5614(b) (Supplies and Materials):
All supplies and materials . . . shall be purchased only after advertisement as provided in this section. The authority shall accept the lowest bid, kind, quality and material being equal, but the authority shall have the right to reject any or all bids or select a single item from any bid. . .

- Not Responsive versus Not Responsible
- "Responsibility"
 - Financial Responsibility
 - Integrity
 - Efficiency
 - Experience in the Industry
 - Promptness
 - Performance Ability
 - Presumption you are Acting in Good Faith
- Challenge Can be Based Upon:
 - Bad Faith
 - Fraud
 - Capricious Action
 - Abuse of Power
- How does an Authority defend against a challenge?
- Who is Suing the Authority?

4. Emergencies

Section 5614(d) regarding "advertisement" or "public notice":

Notice may be waived if the authority determines that an emergency exists which requires the authority to purchase the supplies and materials immediately.

- "Supplies and Materials"
 - Notice refers to "services"
 - -5614(a), (b) or both?
- What is an emergency?
 - Whatever the authority determines?
 - Commonwealth procurement guidance:
 - · Threat to public health welfare or safety
 - "Circumstances outside the control of the Agency create an urgency of need that does not permit the delay involved in using more formal, competitive procedures."
- Who makes the call?
 - Resolution?
 - Staff?
 - General Counsel?
- Defending the "emergency"
