Unemployment Compensation Trust

was established in 1981 exclusively for municipal authorities. The *UC Trust* provides unemployment compensation coverage to more than 270 municipal authorities statewide.

Pennsylvania Unemployment Compensation law requires employers to finance their unemployment compensation in one of two ways:

- 1) as a tax paying employer, or
- 2) as a reimbursable employer.

A *tax paying employer* pays a flat percentage rate each quarter to the Commonwealth, with the average tax rate in 2017 being 6.70%.

A *reimbursable employer* will be billed directly for all unemployment compensation liabilities paid to former employees separated from employment, or opts to enroll in a separate unemployment compensation plan like the PMAA Unemployment Compensation Trust.

All authorities enrolled in the UC Trust become reimbursable employers. The Trust provides authorities with claim services and is responsible for reimbursing the Commonwealth of Pennsylvania for eligible employee claims.
