- Adhere to safe construction practices and take all necessary field measurements
- Utilize Global Positioning System (GPS) equipment to collect and record site-specific physical features for water, wastewater, and or other infrastructure related to development projects
- Facilitate regular coordination with development contractors to ensure proper construction schedules, modifications & connections with existing LCA facilities, new systems testing and disinfection, final inspection, and end-of-maintenance-period inspection
- As a liaison between the public and LCA during construction, including resolving any issues that may arise including preparing property damage and incident reports and notifying customers of any outages or issues
