Dues Structure

Authority member dues are based on gross revenues. Calculated at the rate of one mil for each dollar of gross revenue, plus an administrative fee of \$100. Minimum dues are \$200.00 and include the administrative fee.

If gross revenues are:

- 1.6 - 2 million - dues are \$2,100
- 2 - 3 million - dues are \$2,200
- 3 - 5 million - dues are \$2,300
- 5 - 10 million - dues are \$2,400
- 10 - 20 million - dues are \$2,500
- Over 20 million - dues are \$2,600

These figures include administrative fee.

Leaseback Authorities: Calculated at the rate of one mil on each dollar of lease rental, plus an administrative fee of \$100. The minimum dues are \$200 and the maximum dues are \$995, including administrative fee.

Associate Membership dues are:

- \$175 for first firm individual
- \$ 95 for additional members
